Subject: Establishment of the Cerved VAT Group effectively from January 1st, 2022

This is to inform you that Cerved Group S.p.A. will enter into the so called tax regime of the VAT Group (article 70- bis Of Presidential Decree no. 633, 26 October 1972). With this regime Cerved Group S.p.A. and all its own Italian subsidiaries, will become a single and autonomous VAT taxable person, as follows:

CERVED VAT GROUP

Group VAT number 12022630961

valid for all participating companies which replaces, for VAT purpose, the VAT numbers currently in place at Entity level, effectively from January 1st, 2022.

The establishment of the CERVED VAT GROUP is effective from January 1st, 2022 and will involve all the Entities listed under Annex 1. The latter is also available at the following internet link: https://company.cerved.com/it/gruppo-iva

For invoicing purpose, Cerved Group's suppliers for deliveries/supplies /sales from January 1st, 2022 are required to use the new Group VAT number (12022630961) in addition to the Tax Identification Number (TIN) currently in place at each Entity level (this is not changing).

As a result of the above, all <u>electronic</u> invoices received from January 1st, 2022 by Cerved Group's Entities belonging to the CERVED VAT GROUP, must have the following fields:

Based on the above, we kindly ask you to update the data available in your systems for invoicing purposes. Invoices issued to any of the Entities belonging to CERVED VAT GROUP from January 1st, 2022 still reporting the (old) VAT number of the Entity, rather than the new Group VAT number, will not be accepted, and we will ask for correction through a debit note.



Invoices issued by Entites belonging to CERVED VAT GROUP to your Company, for sales/transactions carried out from January 1st, 2022, will report the Entity name, TIN of the Entity and the new Group VAT number.
